<b>How does Northern Star Lending LLC collect my personal information?</b>	We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>• Apply for a loan</li> <li>• Give us your income information</li> <li>• Tell us where to send the money</li> <li>• Provide account information</li> <li>• Provide employment information</li> </ul>

<b>Why can't I limit all sharing?</b>	You have the right to limit only: <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes – information about your creditworth</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for non-affiliates to market to you</li> </ul>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.

## Definitions

<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and non-financial companies. <i>Our affiliates include other business entities of the Tribe.</i>
<b>Non-Affiliates</b>	Companies not related by common ownership or control. They can be financial and non-financial companies. Non-Affiliates we share with can i
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Northern Star Lending LLC <i>does</i> not jointly market.
