How does Northern Star Lending LLC collect my personal information? Why can't I limit all sharing?	You have the right to limit only: <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworth • affiliates from using your information to market to you • sharing for non-affiliates to market to you
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <i>Our affiliates include other business entities of the Tribe.</i>
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Non-Affiliates we share with can i
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Northern Star Lending LLC <i>does</i> not jointly market.
